HOW CSS MUSIC PLAYER COMPARES IN COST TO PLAYING MUSIC VIA A STEREO SYSTEM IN A PUBLIC PLACE

Playing classic music outside shops and shopping centres to discourage teenagers is a technique that has been used for sometime with moderate effect. This is usually accomplished using a simple in-store stereo music system. This has several drawbacks not least of which is that the speakers used are generally not weather proof.

in addition, many people do not realise that broadcasting music in a public place requires two licenses. One is a license from the PRS (Performing Rights Society) and the other is from the PPL (Public Performance License).

With the CSS MUSIC PLAYER these two licenses are NOT required as the music broadcast is the sole property of Compound Security Systems Ltd.

Below you will see what the annual costs are of purchasing the correct licenses are on an annual basis.

As an example, lets take a shop which including its curtelidge is 100Sq/m.

If one uses a normal music system and downloaded or even purchased music, the PPL fee will be £110.66 + VAT per year and the PRS fee will be £131.40 + VAT per year making a total annual license cost of £242.06.

This is in addition to the cost of the equipment required to broadcast the music externally.

With the CSS Music Player there are NO annual license fees.

This means that to broadcast music via a stereo system in and around a premises of 100 Sq/m will cost £242.06 per year in license fees.

As the CSS Music Player attracts NO license fees the actual cost of the CSS Music Player in the first year is £350 + VAT and £00.00 for all subsequent years.
